## Craft Bazaar Policies and Procedures

### Accommodations:

The accommodations for crafters at The Tillers' Country Fair will consist of 10' by 10' spaces. Spaces are located on both grass and paved area. Tents, tables and chairs will NOT be provided.

### Participants:

All vendors at The Tillers' Country Fair **must have items available for purchase**. Items do not have to be completely handcrafted, though preference will be given to vendors of such items. Due to limited space and overwhelming response, we will no longer accept applications for businesses promoting their services. The Tillers reserves the right to deny vendor applications they deem inappropriate for this event.

### Reservations:

Booth spaces will be reserved upon receipt of the booth space fee and completed and approved application. Availability is limited and will be "first come, first served." A letter of confirmation will be mailed or e-mailed upon receipt of the fee and application.

### Cancellations:

If, for any reason, you need to cancel your reservation, you must do so by August 31 in order to receive a refund of your fee. No refunds will be made after that date. Vendors who are "no call/no show" will not be invited to return.

### Subletting:

Reservations may not be transferred to other vendors without prior approval from The Tillers Nursing & Rehabilitation Center, Inc.

### Set Up:

Participants will receive a set up information one week prior to the event. Any crafter who does not check in by 9:30 will be considered a "no show" and will be treated as such and will not receive a refund for their booth space fee. Participants must be completely set up by 9:30 am.

### Displays and Character of Exhibit:

No sign or merchandise shall be displayed outside the assigned space or interfere with any neighboring exhibits. Use of loudspeakers, wire recorders, televisions sets, stereo systems and radios, or the operation of machinery which is of sufficient volume to annoy neighboring exhibitors will not be permitted. (At the discretion of The Tillers Nursing and Rehabilitation Center, Inc.)

### Parking:

Vendors are required to park in designated areas. Vendors will be directed to these areas on the day of the event. Those vendors with handicapped needs must notify The Tillers prior to the event so that appropriate arrangements can be made.

### Take Down:

Booth spaces must remain open until 2:00 pm, at which time, Participants are free to take down their merchandise and bring their vehicles closer to the craft area. Vendors who do not adhere to this will not be invited to return. The Tillers will not be responsible for items left or stolen.

### Prices:

Prices must be clearly posted at all times.

### Waste Disposal:

All booths are required to properly dispose of their waste materials in the appropriate containers provided. (For larger items, dumpsters are available at the rear of the facility.)

The Tillers' Country Fair does not have a rain date. Refunds will not be issued due to rain or other uncontrollable circumstances.

### Power:

There are very limited power sources. Please inquire for details. Power will not be supplied unless previously arranged with The Tillers Nursing & Rehabilitation Center, Inc.

### Hold Harmless and Indemnification:

The participant agrees that neither The Tillers Nursing and Rehabilitation Center, Inc., or any of its employees, agents or officials shall be liable for injury to the Participant's business or any loss of income therefrom, or from personal injury or damage to the property of the Participant, its employees, invitees, customers, or any other person in or around the Participant's booth regardless of whether injury or damage results from conditions arising from other sources or places, including power outages and other similar occurrences, and regardless of whether the cause of means of repairing the conditions are inaccessible to the Participant. The Participant further agrees that The Tillers Health Nursing and Rehabilitation Center, Inc. shall not be liable for damages arising directly or indirectly from any act or omission of The Tillers Nursing and Rehabilitation Center, Inc. or customer at the event.

To the fullest extent permitted by law, the Participant shall indemnify, keep and save harmless The Tillers Health Nursing and Rehabilitation Center, Inc., its agents, officers and employees against all injuries, deaths, losses, damages, claims, suits, liabilities, judgments, costs and expenses, which may arise directly or indirectly from any negligence or reckless or willful misconduct of the Participant, its employees or agents. The Participant shall at its own expense, appear, defend, and pay all charges of attorneys and all costs and other expenses arising there from or incurred in connection therewith. If any judgment shall be rendered against The Tillers Health Nursing and Rehabilitation Center, Inc. in any such action, the Participant shall, at its own expense, satisfy and discharge the same.

### Insurance and Liability:

The Participant shall carry its own insurance. The Tillers Nursing and Rehabilitation Center, Inc. assumes no responsibility for the safety of the properties of the Participant, its officers, agents or employees from theft, damage by fire, accident of any other causes whatsoever, and the Participant expressly agrees to save and hold harmless The Tillers Nursing and Rehabilitation Center, Inc. and their respective management, agent, and employees from any and all liability resulting from injuries or damage to Participant, its agents, employees and attendees, persons and/or properties in connection with the Participants use of the exhibit space.

Neither The Tillers Nursing and Rehabilitation Center, Inc., its members, employees, agents nor representatives will be responsible for any injury, loss or damage that may occur to the Participant or to the Participant's employees or property from any cause whatsoever.

### Food:

Food/beverage vendors are not permitted at the fair. Baked goods (such as ready to eat cookies, breads, etc...) may not be sold. However, packaged food products and mixes (such as products sold by Tastefully Simple, Pampered Chef, and Homemade Gourmet) are permitted.

### Fees:

- \$5.00 off TOTAL fee for any vendor who enters a scarecrow into the Scarecrow Promenade Competition
